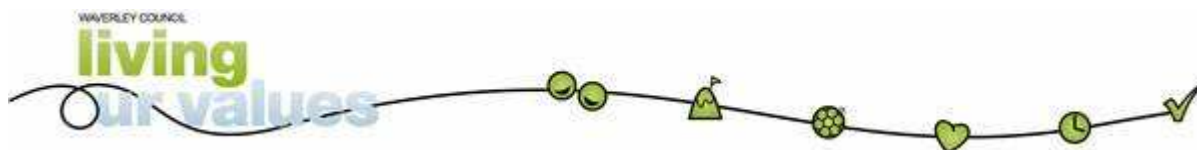
Hi Rosanna
